The information file collection at the Intellectual Property Library consists primarily of articles and newspaper clippings that deal mainly with intellectual property and related topics.

TRADEMARK OPPOSITION JUDGMENTS

A trademark opposition is an objection to a pending trademark application after publication but before a registration has been granted. The Intellectual Property Library houses a small collection of local trademark opposition judgments delivered by the Intellectual Property Office of Trinidad and Tobago between the period 1994 to present.

WIPO DEPOSITORY LIBRARY

In 2017 the IPO was granted depository library status by the World Intellectual Property Organisation (WIPO) based in Geneva, Switzerland. As such, WIPO will provide the IPO with annual publications including: books, magazines, CDs, and reports in various topics. The IPO displays these publications at its library. These publications are available and easily accessible to all users of the library, free of charge, during library operating hours. A separate area has been designated at the library for those publications which cover the fields of Patents, Trademarks, Designs, Traditional Knowledge, Treaties, Classifications and Annual Reports. The list of publications will be updated frequently with regular additions from WIPO. They are also available for short loan to stakeholders.

TECHNICAL LIBRARY/INNOVATION HUB

The Technical Library/Innovation Hub is a subset of the Intellectual Property Library. This Library will provide innovators with access to high quality technology information from various sources and related services. Services offered would include access to online patent and non-patent (scientific and technical) resources and IP-related publications; assistance in searching and retrieving technology information, training in database search, on-demand searches, monitoring technology and competitors; basic information on industrial property laws, management and strategy, and technology commercialization and marketing.
